## DEALER APPLICATION Information

### Lobird® Dealer Application Information

This document will help you to understand the process and documentation required to become an authorized Lobird,® LLC Retailer. Once Lobird receives your application and documentation it will take 1 to 2 weeks to process and approve your information and set-up an account in our online wholesale shop.

The first step in the process is to complete the Dealer application form provided below. Please complete the application in its entirety. Upon approval of your Lobird® account we will use the information provided here, specifically Primary Contact Name and e-mail, to set-up an account in our wholesale shop that you will utilize when ordering Lobird® stationery at lobird.com/wholesale.

Lobird® is required by law to have on hand your Tax Id, Resale number, a copy of your reseller's license and a signed Resale Certificate. Once you have completed the Dealer Application (Page 2) please forward it along with the signed resale certificate (page 3) AND a copy of your resellers license to Lobird. This information can be faxed to 650-403-1798, it can be scanned and e-mailed to customerservice@lobird.com (in the subject line please type WHOLESale ACCOUNT APPLICATION) or the application and resellers license can be mailed to our offices at:

Upon approval of your wholesale Lobird® account we will contact you and will provide you with the following information.

- 1) A login and password to our wholesale gateway (accessed from our retail webstore), and
- 2) a login and password to be used when checking out of the wholesale website with your order

Once you have this information available you will be able to gain access to our wholesale website where you can view our available products and make your first and all subsequent Lobird® Stationery purchases.

Please note that Lobird has a \$150 minimum purchase amount and we require a credit card payment at the time of your order.

Information regarding processing times and shipping options are available on the Wholesale website. Order generally take 1 to 2 weeks to process and ship. We offer, ground, 3 day, 2 day and overnight shipping. Please let us know if you have a rush situation and we will do our best to meet your timeline. **For Your Information:** A person may be guilty of a misdemeanor under Revenue and Taxation Code section 6094.5 if the purchaser knows at the time of purchase that he or she will not resell the purchased item prior to any use (other than retention, demonstration, or display while holding it for resale) and he or she furnishes a resale certificate to avoid payment to the seller of an amount as tax. Additionally, a person misusing a resale certificate for personal gain or to evade the payment of tax is liable, for each purchase, for the tax that would have been due, plus a penalty of 10 percent of the tax or \$500, whichever is more.
